Course Overview:

The course fundamental studies are process and models of policy communication and policy advocacy. The discussion will contain material regarding the policy communication process including its elements, as well as models, forms and techniques of policy communication. In addition, the understanding, processes and models of policy advocacy as well as forms and techniques of policy advocacy will also be studied.

The teaching method used refers to Student-Centered Learning with the main methods used being flipped classrooms, project-based learning, and group discussions. In a number of lecture sessions it will be conducted in a flipped classroom where students will be given pretests and assignments asynchronously to then be deepened in synchronous meetings with the facilitator (lecturer). In a number of other sessions, students will be given project assignments to work on in groups and then group discussions will be held synchronously to discuss and discuss project assignments from each group. The learning method will be carried out entirely online or in a combination of online and offline (if the situation permits). In meeting sessions that use the flipped classroom teaching method, the synchronous session will end with a post-test to determine the level of student understanding of the material provided. Furthermore, the answer keys and feedback will be delivered asynchronously to serve as material for students to reflect on. While in meeting sessions that use project assignments and group discussions, measurement will be carried out through assignment rubrics and discussion rubrics. Feedback on project assignments will be carried out synchronously during group discussions. In this course, the language of instruction used is English and most of the references material provided will be in English.
